Big Win on Transit 2025/2026 Terms and Conditions

AGREEMENT TO OUR LEGAL TERMS

We are 511 Contra Costa, a program of the Contra Costa Transportation Authority

We operate the program Big Win on Transit "Program", as well as any other related products and services that refer or link to these legal terms (the "Legal Terms") (collectively, the "Services").

Big Win on Transit is a sweepstake, organized by 511 Contra Costa and Contra Costa Transportation Authority, that encourages transit ridership in Contra Costa County, CA with a drawing of \$511 weekly from January through September of 2025. Transit riders have a chance to win the \$511 weekly drawing by logging their transit trips and showing proof of a ride.

No Purchase Necessary: Open only to those who live or work in Contra Costa County, California, who are at least 18 years old. No purchase of a transit trip necessary. To enter each weekly drawing without purchasing a transit ticket or riding transit, send a postcard with your name, email address or phone number, and mailing address to: Big Win on Transit, 3003 Oak Road, Suite 100, Walnut Creek CA 94597.

- The weekly prize is \$511 for all weeks during the 2025/2026 program year ending June 2026. Additional drawing chances or prizes may be offered for transit ridership on Spare the Air days in the Bay Area.
- Odds of winning is dependent on the number of weekly entries.
- Selected weekly winners will be contacted by the email address and phone number provided by the participant to confirm a mailing address. Prizes will be mailed to the

participant-provided mailing address. 511 Contra Costa and Contra Costa Transportation Authority are not responsible for participant-provided email, phone or address errors that result in failed delivery of a prize.

- Prize checks are mailed via FedEx. In the event a check is lost, applicants may request a replacement check, and the original check will be voided. Unless due to an administrative error by the 511 Contra Costa Program, replacement checks incur a minimum fee of \$18, which will be deducted from the amount of the replacement check.
- It is the individual taxpayer's responsibility to report any prize winnings over \$50 in value. No reporting by 511 Contra Costa will be required under \$600 in total prizes to an individual in a tax year.
- Weekly winners' first names and cities may be posted on the 511 Contra Costa website and social media once they've been confirmed.
- Employees and agents of 511 Contra Costa, Advanced Mobility Group, and Contra Costa Transportation Authority are not eligible to win.

10. SERVICES MANAGEMENT

Except where otherwise required by the applicable AAA rules or applicable law, the arbitration will take place in Contra Costa County, California. Except as otherwise provided herein, the Parties may litigate in court to compel arbitration, stay proceedings pending arbitration, or to confirm, modify, vacate, or enter judgment on the award entered by the arbitrator.

If for any reason, a Dispute proceeds in court rather than arbitration, the Dispute shall be commenced or prosecuted in the state and federal courts located in Contra Costa County, California, and the Parties hereby consent to, and waive all defenses of lack of personal jurisdiction, and forum non conveniens with respect to venue and jurisdiction in such state and federal courts. Application of the United Nations Convention on Contracts for the International Sale of Goods and the Uniform Computer Information Transaction Act (UCITA) are excluded from these Legal Terms.

In no event shall any Dispute brought by either Party related in any way to the Services be commenced more than one (1) years after the cause of action arose. If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that

If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that portion of this provision found to be illegal or unenforceable and such Dispute shall be decided by a court of competent jurisdiction within the courts listed for jurisdiction above, and the Parties agree to submit to the personal jurisdiction of that court.
